- b. A PSLA listserv email announcing the 2017 candidates was sent out on January 25, 2017. During January 2016, a "Meet the Candidates" article was posted under recent news on the PSLA website. On January 25, 2017, an electronic ballot notification was sent out to all active members of the Association announcing the 2017 candidates for Vice President, two-year Directors and a one-year Director. Voting instructions were emailed on January 25, 2017 and electronic voting began on January 25, 2017. Five additional notices were also sent out for reminders as well as the PSLA listserv and twitter reminders. The deadline for voting was midnight on February 15, 2017. A total of 318 ballots were cast, eighteen ballots were marked invalid due to duplicate votes from the same person. Laura Wienand and Bob McConnell verified the votes. Therefore, 300 votes were accepted. 39% of the active members voted. There were 714 active members, 28 retired active and 25 outstanding contributors for a total of 767 active members. (Note: In the last two years, the percentage of active members who voted has increased.)
- c. Notification was sent to all candidates. Newspaper articles will be sent for the successful candidates
- d. These candidates will be inducted into office at the annual conference in Hershey at the General Session on March 30, 2017 and will assume office on July 1, 2017.
- e. Election of Officers Candidates for Officers and Directors' positions on the PSLA Board are as follows:
 - i. Vice President: Cathi Fuhrman (four-year term)
 - ii. Two- year Directors: Robin Burns and Craig McFeely
 - iii. One-year Director: Jamie Scott
- f. Election Results of the PSLA Bylaws Amendment

i. There were 294 valid votes and 98% of the members voted in favor of the bylaws amendment as recommended by the Board.
